The Bihar Industrial Area Development Authority (BIADA) invites Expression of Interest EOI-cum-RFP from eligible and experienced agencies for preparing a Detailed Project Report (DPR) for the construction of 2 million Litres per Day (MLD) Common Effluent Treatment Plant (CETP).

The CETP is envisioned to serve industries located in Leather Cluster, Bheriadangi by providing an efficient and environmentally compliant solution for treating industrial effluent.

The DPR will guide the design, development, and implementation of the CETP, ensuring compliance with all applicable environmental norms and regulations.

Eligibility Criteria

Interested agencies must meet the following criteria:

1. Experience and Expertise:

- Minimum 2 DPR preparation for waste water treatment projects (ETP,STP,CETP,etc) in the last 2 years for projects in Bihar.
- Demonstrated expertise in environmental engineering, wastewater treatment technologies, and effluent management systems.
- Provide supporting documents, including project completion certificates or client testimonials.
- Minimum average experience of the bidders shall be of not less than 10 years working in the field of Environmental management and pollution control. (Preferred notification from MOEFCC/CPCB)

2. Technical Team:

The agency must have a multidisciplinary team of qualified professionals, including:

- Environmental Experts with minimum qualifications of MSc/ PhD in subject related to environment with minimum experience of 10 years
- Civil Engineers/Mechanical Engineers/Electrical Engineers
- Financial Experts with experience in cost estimation and financial modelling

3. Regulatory Compliance Knowledge:

• Familiarity with national and local environmental regulations, including [specific regulations, e.g., CPCB/SPCB guidelines].

4. Financial Standing:

- Minimum annual turnover of INR 4.5 crore in the last three financial years.
- Provide audited financial statements or CA-certified turnover certificates as proof.

5. Legal Requirements:

- Must be a registered entity in Bihar.
- Provide copies of the following:
- Registration Certificate
- PAN Card
- GST Registration

General Conditions

- Government institutions and semi-government enterprises in the related fields may also apply for empanelment.

Disqualifications

- Submitted a proposal that is not accompanied by required documentation or is non-responsive;
- Failed to provide clarifications related thereto, when sought;
- Blacklisted/Declared ineligible to participate in their tendering process by the Government.

Evaluation Criteria for Selection

Interested agencies are required to submit:

1. Technical Proposal:

Applicants shall submit proposals in duplicate in English with all the documents in a sealed cover. The copies of certificates in proof of experience turn over etc., to be self-certified by the Authorized Representative of the firm.

Process of Evaluation Criteria for Selection

1. **Preliminary Screening:** Evaluation of submitted EOIs against following eligibility criteria.

- 2. **Technical Evaluation:** The "Technical Evaluation" shall be done for the technical aspects in accordance to evaluation criteria mentioned above and ranking will be given. Securing minimum 70 marks is required to be eligible for financial evaluation.
- 3. **Financial Evaluation:** Price of the top three agencies securing maximum marks will be opened and least quoted price shall be designated as L1.
- 4. **Agreement & Submission of EMD:** L1 Bidder has to submit the EMD of Rs 1.00 lakhs on the behalf of BIADA, Patna and has to sign an agreement.

Scope of Work

The selected agency will undertake the following tasks:

1. Data Collection and Analysis:

- Conduct surveys to collect data on effluent generation, characteristics, and discharge patterns from industries in the region.
- Assess the suitability of the available land space at the proposed site for the CETP.

2. Preliminary Studies and Feasibility Analysis:

- Conduct technical and financial study for availability of resources and raw material for the smooth operation of the project.
- Identify and propose appropriate CETP technologies based on effluent characteristics and treatment requirements.

3. Preparation of DPR:

- Provide detailed engineering designs and layouts.
- Estimate project costs (CAPEX and OPEX).
- Include a plan for sludge management, salt management, energy optimization, and environmental compliance.
- Prepare an implementation schedule with key milestones and timelines.
