Technical Evaluation Outcome:

On 30th April 2025, the Tender Committee convened to evaluate three (3) bidders based on the pre-qualification criteria outlined in "Annexure I: Parameters for Evaluation of Pre-Qualification" of the RFQ cum RFP. The proposal submitted by Assystem India Ltd. failed to meet the minimum qualification requirements, whereas Voyants Solutions Private Limited and EGIS India Consulting Engineers Pvt. Ltd. fulfilled the stipulated criteria.

Following the completion of the pre-qualification phase, the Tender Committee, on 2nd May 2025, conducted the technical evaluation of the pre-qualified bidders, namely 1. Voyants Solutions Private Limited and 2. EGIS India Consulting Engineers Pvt. Ltd., in accordance with the criteria specified in "Annexure II: Parameters for Evaluation of Technical Proposal" and "Annexure III: Parameters for Qualification and Competence of Key Personnel (Core Team)" of the RFQ cum RFP. A scoring exercise was subsequently carried out, with marks assigned as detailed below:

As per the RFQ cum RFP a minimum technical score of 70 points out of 100 is required to qualify in the technical evaluation. Based on this criterion, the Tender Committee unanimously recommended two bidders, namely 1. Voyants Solutions Private Limited and 2. EGIS India Consulting Engineers Pvt. Ltd., as technically qualified.

Financial Evaluation:

Based on the technical scores achieved and in accordance with the terms and conditions stipulated in the RFQ cum RFP document, the Tender Evaluation Committee recommended opening of the financial bids of the two (2) technically qualified bidders, namely 1. Voyants Solutions Private Limited and 2. EGIS India Consulting Engineers Pvt. Ltd.

Consequently, the financial proposals of these two (2) technically qualified bidders were opened before Tender Evaluation Committee, with the details as follows:
