### **Terms of Reference (TOR) for the Chartered Accountant firms**

An indicative list of services (including but not limited to) which would be expected to be offered by the selected "CA Firm" are as follows:

Internal Audit of the Annual Accounts of Bihar Industrial Area Development Authority (BIADA ) for the Financial Years 2024-25, 2025-26 and 2026-27.

- (i) To Provide an independent and unbiased view, adding value to "BIADA".
  - a) To objectively review BIADA's Policies and procedures, and to provide assurance regarding compliance with the policies and procedures of BIADA and that these processes are adequate in mitigating risks of BIADA.
  - b) To improve the control environment of BIADA by assessing its efficiency and operating effectiveness.
  - c) To regularly perform audit, to ensure compliance with any and all relevant laws and regulations.
  - d) To audit of books of Accounts, Ledgers, Vouchers including other areas in accordance with Standard on Internal Audit issued by ICAI for evaluation of Internal Finance Control of the Company.
- (ii) To conduct the Audit of BIADA's Cluster as well as BIADA Head Office.
- (iii) To verify the Cash Book and Bank Book and other relevant books and documents.

- (iv) To prepare Annual Financial Statement/Reports of aforesaid periods which to be placed before the Management/ Board of the Company.
- (v) Preparation of reconciliation statement of the deduction and reimbursement to the concerned department including verification of accuracy thereof made by the authority on the payment to its clients/ contractors and staffs and also checks the returns duly filed as per relevant provisions.
- (vi) Audit of the statutory compliance like EPF, TDS, GST etc. as may be applicable.
- (vii) To train and guide the staff of BIADA in the area of taxations and other matters.
- (viii) To audit the compliances to the notices received by BIADA in all matters relating to the Income Tax/TDS/GST including the assessment/ reassessment proceedings.

Joint Venture / Consortium of Firms will not be allowed for participation in the selection process. The eligibility criteria are as follows:

- The Chartered Accountants (CA) Firm should be a Partnership Practicing Firm of Chartered Accountants.
- The CA Firms should be in Practice for a period of 5 years or more.
- Have at least 2(Two) fulltime FCA partners/employees who are associated with the firm for more than 2 (Two) years, out of which 1 (one) partner should be stationed within Bihar.
- Have average professional fees of Rs. 20 (Twenty) Lakhs or above in the last 3 financial years 2021-22, 2022-23, 2023-24, (Financial Statements to be submitted)
- Should have never been issued notice for failure to submit deliverables and cancelation of work order, forfeiture of EMD, etc. by any Government
