Point no. 1. M/s Jay Ambe Industries was allotted Plot no. D-65 having area 5820 sqft at IA Hajipur vide letter no. 492 dated 22.02.1999 for establishment of tea processing and packing unit. Due to shortage of land unit had given possession of 1740 sqft of land only. Later on, unit was cancelled vied memo no. 3171 dated 22.09.2021 due to non-working of the unit. Unit had filed an appeal in Hon Appellate court passed an order on 18.02.2022. In that order Court had directed BIADA to give 5820 sqft of land to the unit without any amount from them.

In light of that order unit has given a request on 16.03.2022 to give only 4080 sqft land and leaving the earlier allotted land having area 1740 sqft as they have invested on the earlier allotted 1740 sqft land.

DGM- Hajipur proposed to allot Plot no. NS having area 4080 sqft in IA Hajipur.

Approval from Competent Authority to put up in PCC on E-File no. E-119750 Hence, above proposal may be approved by the committee.

Decision Taken: - Approved.

Point no. 2. DGM SBI (B&O) Bhagalpur office, has demanded land admeasuring 10000 – 20000 Sq.Ft area in LIE Barari for administrative office and opening new branch.

DGM- Bhagalpur proposed not to allot land because there is no provision for giving land for building service sector and office in the current land allotment policy.

Approval from Competent Authority to put up in PCC on E-File no. E-443380. Hence, above proposal may not be approved by the committee.
