

Point no. 1 M/s PURNIA AUTOS

M/s Purnea Autos allotted plot no. 25(Part), having area 0.50 acre for Repair & maintenance of automobile at IGC Maranga vide allotment letter no. 537 dated 08.05.2002.

Proposal:

- M/s Brajesh Automobiles Pvt. Ltd. requested for transfer of this land from Purnia Autos.
- They plan to set up an EV Components manufacturing unit along with the earlier registered project.
- Proposed project cost: ₹8 crore.
- Employment potential: ~50 persons.
- A detailed project report (DPR) has been submitted.
- Land transfer may be approved for the remaining lease period, subject to mandatory payment.

To put up the matter in PCC on E-File no. 292795 has been received.

Hence, above subject matter has been put up before committee for decision.

Decision Taken: - Approved.

Point no. 2: A.K. Knitwears

- A.K. Knitwears was allotted 12,420 sq. ft. of land (C-11(P-II), C-12) on 16.03.2024, in Industrial Area Sitamarhi and physical possession was handed over on 06.05.2024.
- This land was earlier allotted to Mahavir Enterprises, who surrendered it under the Exit Policy-2023.
- The pre-existing structure on the plot was valued at ₹6,46,360/-, which was to be recovered from the new allottee (A.K. Knitwears) and paid to the previous allottee.

- The new allottee repeatedly requested waiver of this valuation amount and sought time for execution of the lease deed.
- During a committee inspection on 08.08.2025, the existing structure on the said land parcel is being demolished to construct a new structure. Only a partial portion of the boundary wall remains of the existing structure. In such a situation, it is not possible to re-evaluate the previous structure.
- Based on reports, the committee suggested, if possible, that since A.K. Knitwear did not utilize the old structure, the valuation amount **may be waived**.
- However, the legal review stated that under the Exit Policy, the valuation amount must be recovered from the new allottee, and BIADA had not yet paid the previous allottee.

To put up the matter in PCC on E-File no. 416072 has been received.

Hence, above subject matter has been put up before committee for decision.

Decision Taken: Deferred.
