Miscellaneous:

Point no. 1: Subject: Summary of Case – M/s A.K. Knitwear's, Industrial Area, Sitamarhi (Valuation Amount Issue).

- Allotment Details:**

Land admeasuring 12,420 sq. ft. (Plot No. C-11(P-II), C-12) at Industrial Area, Sitamarhi was allotted to M/s A.K. Knitwear for establishment of Hosiery Goods industry vide letter no. 2190/D dated 16.03.2024. Physical possession was handed over on 06.05.2024.

- Background of Land:**

The said plot was earlier allotted to M/s Mahavir Enterprises and was surrendered to BIADA under Exit Policy-2023.

- Valuation of Existing Structure:**

A valuation of Rs. 6,46,360/- was assessed for the pre-existing structure on the plot and was demanded from the new allottee as per Exit Policy provisions.

- Objection by the Unit:**

M/s A.K. Knitwear's repeatedly objected to the valuation amount and requested its removal, raising the issue in Grievance Redressal Meetings and through several representations.

- **Inspection & Committee Reports:**

Multiple inspections were conducted (notably on 08.04.2025 and 30.07.2025). Committees observed that the new allottee did not use the existing structure, and the main structure had already been demolished.

- As per third inspection report dated 26.11.2025 (Letter No. 716) and joint inspections conducted on 08.04.2025 and 08.08.2025, it was observed that the main structure had already been demolished. The existing structure was not utilized by the present allottee and had no practical industrial use. Accordingly, the inspection authorities opined that the earlier valuation by the Registered Valuer is not justifiable.

- **Recommendation of Committees:**

Based on reports, the committee suggested that since A.K. Knitwears did not utilize the old structure, the valuation amount may be waived off.

- **Outstanding Dues:**

Apart from the valuation amount, the unit has other outstanding dues of Rs. 29,224/-.

- **Lease Deed Application:**

The unit has already applied for execution of the **Lease Deed**.

- **PCC & Current Status:**

The matter was placed before PCC earlier and deferred. It has now been proposed to be placed again before PCC for a final decision in light of updated reports.

To put up the matter in PCC on E-File no. 416072 has been received.

Hence, above subject matter has been put up before committee for decision.

Decision Taken: Approved: Letter from concerned cluster to be issued to allottee regarding waiving off the valuation amount. The same may be placed before BIADA Board for post facto approval.

Point no. 2: Subject: Regarding Existing structure on allotted Plot No. 87 (P-1), Industrial Area Forbesganj, M/s Get Nextg Lifestyle Private Limited.

- M/s GET NEXTG LIFESTYLE PRIVATE LIMITED has been allotted Plot No. 87 (P-1) at Industrial Area Forbesganj, measuring 13,068 sq. ft., vide BIADA letter dated 25.09.2025, for establishment of an E-Waste Management Unit. The said plot was earlier allotted to another unit, and a pre-constructed structure exists on the allotted land.


- **Observation of Committee:** -

Committee is of the opinion that if the structure will be used by the unit M/s GET NEXTG LIFESTYLE PRIVATE LIMITED, then unit has to pay valuation amount of existing structure else structure shall be auctioned by the concerned cluster.

As informed by DGM-ID, Purnea Cluster, BIADA that unit in his letter dt. 06.10.2025 informed that existing structure is of no use to them and they need to remove the structure to start their construction work.

- **Recommendation of the Committee:** -

Accordingly, in view of the above, the Committee, in its report dt. 01.12.2025, recommended that as the existing built-up structure is not required by the unit, the structure constructed on the




said land may be auctioned at cluster level and subsequently removed, thereby enabling the unit to commence its industrial activities.

Hence, above subject matter has been put up before committee for decision.






